The mother added he is fidgety always, restless, irritable, and anxious. Depression was denied although he was heavily affected by their parents which happened a year ago.

Management Plan by Bruce Nsubuga on case Billy Johnson



Discuss with the patient and parent on stimulant medication as first-line of treatment of ADHD

It is crucial to conduct a family history on conditions related to heart diseases, cardiac problems or syncope before prescribing medication.

Use of assessment tools such as Conners rating scale at baseline in diagnoses process to establish and identify pattern of behaviors as well as monitor treatment response.

Monitor weight changes or any other side effects that might be attributed by medication.

Recommendation on nonstimulant medication if the patient does respond well to stimulants.

Recommend psychoeducation, family therapy and behavioral therapy such as CBT and interpersonal therapy.
