Problem Statement by Bruce Nsubuga on case Joan Duffy



JD is a 55-year-old female accompanied by the group home nurse with a complaint of hyponatremia (116 mmol/L) and altered level of consciousness (confusion). History reveals the confusion commenced three weeks ago and is accompanied by headache, lightheadedness, polydipsia, stomach upset and nausea, loss of appetite, and unintended weight loss of 20 pounds. She is on paranoid schizophrenia treatment and associates the symptoms with a change of antipsychotic medication to Ziprasidone HCL three weeks ago. Has right lung wheezing, palpable supraclavicular lymph nodes, and auditory hallucination, and smokes 2 packs a day over 40 years.

Management Plan by Bruce Nsubuga on case Joan Duffy



1. Admitted to the hospital for further evaluation and management and release the group home nurse.
2. Orient patient to the ward and Commence hyponatremia management:- 3% saline solution at the rate of 100 cc/hour, restrict water intake to a max of liter a day.
3. Discontinue Geodon, monitor psychotic symptoms, and schedule psychiatric review.
admin acetaminophen 100 mg IV and Zofran 4 mg IV to alleviate headache and nausea respectively.
(Yasir & Mechanic, 2023).
4. Educate patient on the nature of the condition, treatment regimen, need to stop smoking, and adhere to the scheduled medications and evaluations.
5. Refer patient to an oncologist for a thorough evaluation of the lung neoplasm.
6. Discharge plan: she can be discharged to her group home with a daily-fluid restriction of 1.5 liters. Follow-up with oncology should be scheduled in two weeks to monitor the lung neoplasm and the patient's overall progress.
