EW neither raises her hand nor answers questions. She snores more nowadays and her eating behaviors have changed whereby she loves eating carbs like noodles, and crackles. The patient is irritable and throws fits when not given her favorite food. In her previous school, she was always happy, smiling, and laughing. She cries more often before school, and is restless while sleeping. EW sneaks food from the pantry and cannot express herself and has few friends. She has gained weight and elevated BMI.
